

## **Agreement on Compliance with Operational Safety Provisions (as per Sec. 21 EregG)**

made between

KTL Kombi-Terminal Ludwigshafen GmbH

This Agreement on Compliance with Operational Safety Provisions as per Sec. 21 EregG has been concluded as follows:

1. The RU shall be obliged, prior to the commencement of operations, to conclude a rail infrastructure user contract with the railway network provider BASF SE, where such a contract has not already been concluded and remains valid.
2. The RU hereby confirms receipt of KTL's House Rules (Annex 3 of the TCUSF). The RU hereby agrees to familiarise all employees (i.e. its own employees and those of any contracted third party) with the contents of the House Rules document prior to their deployment on the operational territory of KTL and to ensure that the requirements therein are strictly adhered to. Any violation of the provisions of KTL's House Rules document may result in the guilty employee(s) being barred from the territory for an indefinite period.

3. The RU hereby confirms receipt of Annex 6 of the KTL TCUSF 2018 (Route to Work of the Train Driver). The RU hereby agrees to familiarise all employees (i.e. its own employees and those of any contracted third party) with the contents of Annex 6 prior to their deployment on the operational territory of KTL and to ensure that the requirements therein are strictly adhered to. Any violation of the provisions of KTL's House Rules document may result in the guilty employee(s) being barred from the territory for an indefinite period
